Fred again.. 2024 EVENT CONDITIONS OF ENTRY

- 1. Entry is at your own risk. The right to refuse entry is reserved.
- 2. The Promoter and the Venue shall not be held liable for any loss, injury or damages sustained entering or within the premises.
- 3. There are no pass outs at any Fred again.. Events.
- 4. Small still cameras (including those with a recording function) and mobile phones are permitted for personal use only. Professional still cameras (such as an SLR), professional video cameras (including go-pros), sound recording equipment and professional lighting and tripod set ups are not permitted at Fred again.. without written authority from the Promoters. Please respect the privacy of all other patrons, artists and service providers at Fred again.. when using your camera or mobile phone.
- 5. As members of the audience, ticket-holders consent to being included in photos, sound and live video recordings that can be used by the promoter or promoter approved media outlets for promotion of the event.
- 6. No BYO alcohol, soft drinks, juice, milk, energy drinks, flavoured water or sports water is permitted at Fred again...
- 7. No illicit drugs are permitted at Fred again... Offenders will be referred to police.

- 21. All conditions shown on the ticket are to be read together with all other statements or directives either shown on this ticket or displayed on the premises.
- 22. Refer to Ticketek's terms and conditions for further ticketing details.
- 23. Smoking and/or vaping is not permitted inside or within 10 metres of the external doors.
- 24. If you require assistance raise your arm and/or speak to a staff member First Aid assistance is available. Speak to a staff member in a yellow shirt for assistance if required.
- 25. Moshing and crowd surfing is prohibited. Patrons undertaking these activities may be asked to leave the venue.
